**POLICY AND REGULATIONS FOR USE OF THE URBAN INDIAN CENTER OF SALT LAKE**

**POLICY STATEMENT**

1. The Urban Indian Center of Salt Lake will require lessee to maintain Commercial General Liability Insurance with a minimum of \$1,000,000.00 limit per occurrence. Lessee agrees to maintain and be responsible for all Workers Compensation Insurance for all employees on the premises if applicable. In addition, the Urban Indian Center of Salt Lake and its entities must be named as additional insured on all liability policies.
2. The coverage described is required and must be submitted with the deposit. Applications will be denied for lack of insurance.
3. In the case of a private citizen or unorganized entity, whether or not a usage fee is charged, where commercial general liability insurance does not, and could not exist, the lessee understands that UIC-SL will not be held liable.
4. Rules of Use:
  - a) Full payment must be made before event date. Cash, Check or Money Orders. Payable to the **URBAN INDIAN CENTER OF SALT LAKE**.
  - b) Deposit is refundable if facility is left clean and in an undamaged condition.
  - c) The Urban Indian Center of Salt Lake is a drug free zone. Absolutely no alcohol/drugs allowed on property.
  - d) There will be a \$75.00 cancellation fee if cancellation is made less than 48 hours of scheduled event.
  - e) Maximum occupancy is 350.
  - f) Events after working hours, with 50 + participants, must have a first aid attendant (CPR /First Aid Certified) and Security personnel.
